1) ENTRIES: We are running TWO COMPLETE and separate horse trials. **THE PRICES LISTED ALLOW YOU TO COMPETE IN BOTH EVENTS.** OI \$560, ICT \$160, OP \$560, T \$530, PT \$500, E \$500, PE \$500. **Both events are qualifiers for the BC Summer Games.** You may enter a different level for each event; fees will be for highest level. You may enter just 1 event. **If you are entering just 1 event email Gayle for the price.** PDF Copies of 2020 PTSO, HTBC and EC Sport License or foreign memberships must accompany all entries for riders. Owners must have EC Sport License, PTSO or foreign equivalent. Photos of entries will NOT be accepted. **Refunds:** Before CD, no fee. After CD to May 12, with medical or vet certificate, less \$30. No refunds on Entry or Stabling after May 12. Late or incomplete entries, if accepted, are subject to \$30 administration fee. Cheques payable to Mustang Powder Horse Trials, e-transfers and credit cards are accepted, please send to Gayle. If paying with credit card add \$25.00 to each entry.
